Travel contract and responsibility

The bookings are regulated by the present general conditions, by the law n° 111 of March 1995, by the ECC directive n° 90/314 and by the Italian law n° 1084 of 27 December 1977. The Travel Agency is not responsible for any damages caused by the client.

Prices

Prices on web site www.motorstars.org, update until December 2010 are quoted in €uro and include pick-up/ drop-off, guide, museums/factories entrance with booking and taxes; they do not include any personal expenses or additional fees such as restaurants, merchandising or any other extra.

If total charge will be more than 10% of agreement charge, contract can be cancelled through written communication to MOTORSTARS within cost increase receive.

Special prices

Payments

Change or cancellation of booking by you
